INVITATION TO BID FOR  
PROCUREMENT OF IT EQUIPMENT FOR ITSU

1. The DOSCST, through its *Special Trust Funds* intends to apply the sum of **Three Million Four Hundred Sixty three Thousand Five Hundred Pesos(P 3,463,500.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of Goods2016-12. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DOSCST now invites bidders for the *Supply and Delivery of IT Equipment for ITSU*.<sup>1</sup> Delivery of the Goods is required *Thirty (30) days upon receipt of Notice to Proceed*. Bidders should have completed, within *Two (2) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

5. A complete set of Bidding Documents may be acquired by interested Bidders on September 13, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P 3,400.00**
6. The BAC will hold a Pre-Bid Conference on **September 20, 2016 @10:00 AM** At the TIEC Building which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before **October 3, 2016**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**.

Bid opening shall be on **October 3, 2016 @ 10:00 AM at the TIEC Building.** Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
